

Whereas, Mian A. Jan, M.D., is being honored for providing twenty-five years of dedicated service to the Chester County Hospital and the community at large; and



He practices privately at West Chester Cardiology and also serves as a member of the staff at Chester County Hospital, where he is Chairman of the Department of Medicine. The Attending Physician in Cardiology at the Pennsylvania Hospital of the University of Pennsylvania Health Systems and Lankenau Hospital, Dr. Jan serves as President of the Chester County Medical Society, and he is certified by the American Boards of Internal Medicine, Internal Medicine for Cardiology, Disability Analysts and Internal Medicine for Interventional Cardiology. A Fellow of the American College of Cardiology and the Society of Cardiovascular Angiography and Intervention, Dr. Jan is a member of the American Society of Nuclear Cardiology, the Alumni Association of Temple University, the Pennsylvania and Chester County Medical Societies, the Society of Cardiovascular Computed Tomography and the Executive Committees of the LifeCare Hospital of West Chester and the Chester County Hospital. 




